# **General description**

The Hairstyling Instructor is responsible for delivering instruction and hands-on training to students pursuing a career in the hairstyling industry. This role involves teaching a wide range of hairstyling techniques, including haircutting, coloring, styling, extensions, and wig applications, while ensuring students gain the skills, knowledge, and confidence required to succeed in the profession.

- 1. Diploma in Hairstyling, or Certificate of Qualification as a Hairstylist
- 2. Specialization in Foundational styling an asset
- 3. Hairstylist license for a minimum of 5 years
- 4. Post-secondary teaching experience, curriculum development, and/or an education degree is an asset
- 5. Minimum 5 years of current industry work experience
- 6. Demonstrated Cultural and Intercultural knowledge and competency
- 7. Strong interpersonal skills to work within a collaborative team environment
- 8. Excellent leadership, coaching, mentoring, and presentation skills
- 9. Strong commitment to academic excellence and student success
- 10. Strong customer services skills
- 11. Excellent computer skills including Microsoft 365.

#### Job duties/responsibilities

- 1. Teach and demonstrate hairstyling techniques, including haircutting, coloring, styling, extensions.
- 2. Provide hands-on training and supervision to students in both classroom and salon settings.
- 3. Develop lesson plans and instructional materials that meet program and industry standards.
- 4. Assess and evaluate student skills and progress through practical and written assessments. 5. Mentor and coach students to support skill development, professionalism, and confidence.
- 6. Maintain a safe, clean, and professional salon learning environment.
- 7. Incorporate cultural and intercultural awareness into instruction and student interactions.
- 8. Stay current with new trends, products, and practices in the hairstyling industry.
- 9. Model professional standards, customer service skills, and workplace readiness for students.
- 10. Use Microsoft 365 and learning management systems (e.g., D2L) to support instruction and communication.

11. Participate in team meetings, training, and program improvement activities.

# **Working conditions**

- 1. Perform moderate physical tasks that require repetitive use of hands.
- 2. Opportunity to alternate body positions intermittently, with moderate intensity of concentration and attention to detail required while hairstyling and instructing.
- 3. Engage in tasks that require moderate dexterity, including both coarse and fine motor movements.
- 4. Experience frequent, low-risk exposure to hairstyling chemicals and products.
- 5. Incumbent works indoors in climate-controlled conditions.
- 6. May be exposed to noise, and on rare occasions to behaviourally difficult students, clients, and members of the public.
- 7. Hours vary based on operational requirements with occasional evening or weekend commitments.
- 8. Occasional lifting of up to 10 lbs required.
